Ward 2, CM Sharpe, Finance Chairman

CM Sharpe: commented on the flyers that were handed out for the change in trash schedule due to the Holiday on this past Monday, thank you to Public Works. CM Sharpe stated that the soliciting signs on the telephone poles and medians are beginning to be a big problem and to please keep an eye out on trying to prevent people from putting them up. CM Sharpe commented on the broken door, at the University of Maryland building that is vacant and is a current crime risk. Mr. Prangle commented that Mr. Duncan is very much interested in seeing the building razed and is sure that he will take care of the problem.

CM Lingua commented on the curbs and sidewalks by the elementary school, and stated that were are trying to make it aware that it is an elementary school, so that fewer will speed through causing great danger to the children. CM Lingua stated that residents please have patience when passing through the area, and to please meet you kids at the crosswalks and have you children cross on the crosswalks rather than crossing in the

middle of the street. CM Lingua commented on Michael Scott and the Public Works staff for doing a great job in taking care of everything, thank you.
