Mayor Archer stated that we are contracting with Reese to do the title search on the properties along the trail. Mayor Archer stated that there have been a number of dead chickens found along the railroad track, by the crossing of Queensbury Rd. Mayor Archer stated that Code Enforcement and the Police Department have been working with animal control to try and minimize the problem. Mayor Archer stated that those of you, who see the chickens, please call Town Hall, do not pick them up yourselves.

Administrator's Report

Mr. Prangley introduced the new Deputy Town Administrator, Ms. Penny Guzman. Mr. Prangley welcomed her with open arms and commented that she was a liaison for Prince George's County. Mr. Prangley stated that on October 23, 2007 at 6:00p.m., there will be a meeting on Economic Development and safety at 6200 Sheridan St. Mr. Prangley stated that the Weather Control and Climate Center is moving along very quickly.

Mayor Archer stated that the connection with the Town and the Fire Department is through a Charter. Mayor Archer stated that the volunteers elect their officers, and the Town is subject to approval. Mayor Archer stated that the Town gives the Fire Department an annual grant of \$10,000, to keep the building maintained. Mayor Archer stated that the recent event that was broadcasted on the television was a personnel issue. Mayor Archer stated that we are very concerned on what happened and how it was addressed, what happened afterwards, what will happen next, and what we need to do to move forward.

Fire Department Report

Mr. Vince Harrison, Chief of the Fire Department gave the Fire Department Report. (Copies Available)

Mr. Harrison spoke about the incident that happened on Saturday, September 15, 2007. Mr. Harrison stated that there were some individuals doing some immature things, playing with alcohol foam. Mr. Harrison stated that alcohol foam will not hurt you. Mr.

Harrison stated that one individual's pants caught on fire, and resulted with a 2nd degree burn on his back. Mr. Harrison stated that this individual was involved in playing around, and got hurt. Mr. Harrison stated that the other two individuals who were active in this immature behavior were given the maximum amount of suspension that is able to be given. Mr. Harrison stated that the individual who got hurt did not say anything for 2 days, before telling another fire department. Mr. Harrison stated that after hearing what happened immediate action was taken place. Mr. Harrison again stated that alcohol based foam, is to be used to wash your hands. It will burn you if you let it burn, but not if you put it out right away. Mr. Harrison stated that the fire house cares, and are going to continue to care. Mr. Harrison stated that this is a black eye in our eye, and we are going to continue to go forward. Mr. Harrison stated that we are going to do the best that we can.

The Mayor and several members of the council expressed concerned about the incident and requested that the government be updated about the results of the county investigation now in progress. Concerns noted by council members included the need to hold department volunteers accountable to a professional code of behavior, the need to limit and protect against potential legal liability of the Town of Riverdale Park, and the need for revised policy in the fire department regarding young adults. Mayor Archer thanked the Chief, men and women of the Fire Department. Mayor Archer stated that he appreciates everything that the Fire Department is doing and putting themselves on the line for the Town.

Ward and Committee Reports

Ward 1, CM Walker, Economic Development

CM Walker stated that would like to call attention and thank the Police Department for the additional coverage on the train tracks and Dumm's Corner, where a lot of drinking and unsavory behavior has been happening. CM Walker stated that she has been talking with Public Works and they have cleaned up the trash in that area about three times in the past five weeks, and containing mostly in the trash, are alcohol bottles. CM Walker stated to please call the Police Department if you have any complaints. CM Walker stated that Park & Planning has had all of their pumpkins stolen from the Mansion, and a resident is having everything picked out of her garden. CM Walker stated that if you see something that you are concerned about please contact us. CM Walker thanked Code Enforcement and the Police Department for getting the cars off of the grassy area on Cleveland Ave. CM Walker stated that the Town is pursuing on getting lighting at the Pepco pole on Ravenswood and under the bridge of East West Hwy. CM Walker asked if there had been any updates on CSX.

Mr. Scott: There have been no updates from CSX.

Mr. Prangley: As far as the improvements, they have told us late fall.

CM Walker stated that Riverdale Park Day is on Saturday, October 6th, 2007. CM Walker stated that if you would like to volunteer it is a lot of fun.

Ward 2, CM Sharpe, Finance Chairman

CM Sharpe stated that she would like to highlight a few things that were looked over at the Finance Committee meeting on September 25th, 2007. CM Sharpe stated that the town's purchase system was looked at, and the Town uses checks with the exception of a few accounts that we have credit with. CM Sharpe stated that they are looking at obtaining a Town credit card, which would enable us to make purchases on the internet, and to make purchasing a little bit easier. CM Sharpe stated that the purchases would have the same scrutiny as the voucher system which would be obtained. CM Sharpe stated that there will be a Block party this month at the corner of 49th Ave. and Sheridan St., we are not sure on the specific date yet, but a flyer will be sent out soon. Please contact CM Sharpe, Danielle, or Marietta for more information. CM Sharpe stated that there has been an increased amount of litter and vandalism on Lafayette Ave. and encouraging all residents to contact the Police Department if you see anything. CM Sharpe stated that as far as the turf field that was proposed for the Riverdale Park, there are some plans in the works for the field, and MNCPPC will be in sometime this month or November to answer questions residents might have. CM Sharpe stated that the road improvement project will be moving to Taylor Rd. next, and any residents who would like to have a curb cut and apron please contact me.

This concludes Ward 2, CM Sharpe's Report.

Ward 3, CM Lingua, Public Works

CM Lingua commented on the Public Works report and would like to commend the report that is being given, and to please keep up the good work. CM Lingua stated that there was a Public Works Meeting on September 19th, 2007, and the next Public Works Meeting will be on Monday evening, October 22nd, 2007 at 7:00p.m. CM Lingua stated that if anyone sees areas where it is dark, it may be due to the tree canopy that is lower than the street light. CM Lingua stated that if you do notice these tree canopies, to please contact Public Works. CM Lingua stated that Riverdale Park Day is this Sunday, so come on out, and see the bikes raffle Public Works is putting together. CM Lingua stated that there are new speed humps on Nicholson St. CM Lingua stated that he has heard from some residents that they feel that essentially there should have been more, or placed differently.

CM Lingua stated that he has spoken with Mr. Scott and he said that due to the trees on Nicholson St. they are in the way for more signs to be put up to indicate the speed humps. CM Lingua states that since more signs are not able to be installed due to the amount of trees, more speed humps can not be put in. CM Lingua stated that the Shoemakers have installed a communications tower on their property; this is a communications tower with 0.03 watts of signal. This is less than the amount that comes out of a cell phone. CM Lingua stated that it is not a health hazard and should not interfere with your electronic equipment at home. CM Lingua stated that the owner of the Danor Property is looking into to getting the property divided into eight lots.

CM Lingua stated that we have found the requirement for a cul-de-sac is 50ft. in diameter, and the owner is proposing 35ft. in diameter. CM Lingua stated that the owner is requesting for a letter be composed due to this project. The owner has not received any type of certifications from fire rescue, or from public works. The only acknowledgement the owner has received is from the Director of Public Works two years ago. CM Lingua stated that the owner is still going to try, and will be back on October 29, 2007 at the Work Session Meeting. CM Lingua stated that the challenge has been raised, on which ward is going to have the better lights for Christmas Time.

Ward 4, CM Henry, Public Safety

CM Henry stated that this has to be the most pleasing report from the Police Department that he has heard in quite a while. CM Henry stated that he would like to comment Acting Chief Timmons. CM Henry stated that it is a great step in the right direction, and whatever you are doing, keep up the good work. CM Henry stated that the second public safety meeting was on September 22, 2007, and had a lot of good substance coming out of the meeting. CM Henry stated that he has noticed that the street lights on Patterson St. are completely out. CM Henry stated that he would like to welcome the new Deputy Town Administrator, and is looking forward to working with her.
